In pondering what could be done, a local retired attorney, a friend of mine, who was "mad as hell" about the attack on our church, began to research this as only a retired attorney could. Countless hours were spent looking to discover the way to make the greatest impact and strike at the core of the issue; the core of this "legal" issue.

When he put his plan of action together, he met with several of us about the action he was about to take and how we could do something that would echo and reinforce its impact. His plan was ingenious!

There's an interesting bit of power that the general public tends to overlook and seldom uses to let its voice be heard when it has been wronged. Texas has numerous trades that require a professional license in order to be able to operate in the State of Texas. The list includes such professions as: barbers, massage therapists, real estate agents, insurance agents, lawyers, physicians, plumbers, electricians, etc. These specialized trades have certain rules, requirements, code of ethics, and other necessary regulations that hold the licensees to a standard in which they must operate within or they will lose their ability to work in that field. You probably noticed that one of them I listed was lawyers.

What that Houston attorney did was unethical and he violated several disciplinary rules and the code of ethics. While the tendency is to step back and rejoice that he withdrew the subpoenas and go our merry way, this and other types of abuse and government tyranny will continue unless we (Christians across Texas and the United States of America) start to stand up and say NO! NO we are not going to back off. You violated the rules and we are going to report it! YES - all of us can report it - AND WE SHOULD.

Reporting it means filing a grievance with the State Bar. It's your way of saying that the action that this attorney took was wrong and it needs to be investigated. If thousands of us across the State all file grievances, our VOICE will be heard loud and clear. I hope it will shake the very soul of every attorney in the United States and they will think twice, three times or more before they EVER attack our church again.

Let's keep this simple. My retired friend not only filed his complaint with the State Bar of Texas and has included all the Disciplinary Rules of Ethics that were violated, and various other legal opinions, documents, and news releases regarding the case for all of us to review, he also prepared a document you can download, print out, and simply sign and fax to the State Bar of Texas and JOIN US IN FIGHTING THIS CAUSE. It's that simple. Print out, Sign, Fax Out! The State Bar is required to investigate each and every grievance that is filed. If they receive 1000's from all across the great State of Texas, it will resound with a GREAT VOICE from the citizens that our rights have been violated and it must stop.

Below are the various links you can click and actually read his complete filing with the State and all the supporting documents. There are several other informative links for you also to enjoy in educating yourself on this current topic. But most importantly, there is also the PDF file for you to open, print out, sign and fax into the State Bar. The fax number is included on the file.

As a courtesy from one attorney to another, my friend sent a letter to this Houston attorney stating that he would be filing a grievance with the State Bar of Texas because he had violated several rules of ethics and attorneys are required to report such information to the Bar. About two days after the attorney received this letter, the subpoenas were withdrawn. Hmmm.... Interesting! Coincidence - I think not.

One last note. A grievance being filed must be investigated. There are NO expenses that will be incurred on the part of the party filing the grievance and the person to whom the grievance is filed cannot retaliate against the person filing the report. You will also receive a report back from the State Bar as to the results of their investigation on your behalf. Now that's a letter I'm going to be looking forward to receiving. How about you?

...now that's GOOD NEWS!
